## **Hilly Area Candidate (For State Only): -**

- Domicile certificate of the parent stating that he/she is domicile in the village declared as Hilly area specified in the Table for the respective Regions.
- The Candidate should pass SSC/HSC (or equivalent) examination from School/Junior College situated in the Hilly Area of his/her parent's domicile or if not so, at the most, from a School/Junior College situated in the taluka of his/her parent's domicile.
- Proof showing that candidate has passed SSC/HSC from the same Tehsil/Taluka in the hilly Area of his/her parent's domicile i.e., SSC/HSC passing certificate of School leaving Certificate.

## **ANNEXURE - F HILLY AREA (HA) RESERVATION**

As per G.R. No.MED-1003/CR 641/03/Edu-2, dated 16/3/2004, 3% seats at Govt. / Municipal Corporation Medical colleges are reserved for the candidates from Hilly areas.

In accordance with G.R. issued by the Govt. of Maharashtra MED Dept. G.R. No. MED-1002/3852/CR-617/02/Edu-2, dated 17/4/2003 and resolutions issued by Govt. of Maharashtra from time to time, the candidates claiming seat under HA claim should satisfy following criteria to be eligible:

- Domicile Certificate of the parent stating that he/she is domicile in the village declared as a Hilly area specified in the Table for the respective Regions** (Rest of Maharashtra/Vidarbha /Marathwada, As per the latest list issued by concerned Department) The said certificate should be obtained from the concerned Revenue Department officer (Tehsildar and Above).
- To avail the benefit of HA claim, the candidate must have appeared at NEET UG -2025 examination.
- The Competent Authority shall select the candidates claiming HA, on the basis of their Merit at NEET UG -2025 examination.
- The constitutional reservation is provided under these HA claim seats.
- The candidate should pass SSC/HSC (or equivalent) examination from School/Junior College situated in the hilly area of his/her parents domicile or if not so, at the most, from a School/Junior College situated in the taluka of his/her parent's domicile.**

### **Candidate Under Defence Category (D1, D2, D3): -**

- **Under D1: -**

- 1) Certificate of parent from Zillah Sainik Board.
- 2) Domicile certificate of parent, it should be from within state of Maharashtra.

- **Under D2: -**

1. Certificate of parent from competent authority from defense services stating that Parent is serving as per Army/Navy/Air Force act.
2. Domicile certificate of parent, it should be from within state of Maharashtra.

- **Under D3: -**

1. Certificate of parent from competent authority from defence services stating that Parent is serving as per Army/Navy/Air Force act & transferred and posted in the State of Maharashtra. Domicile certificate of parent of other than Maharashtra is only accepted.



## ANNEXURE - C

### CHILDREN OF DEFENCE PERSONNEL

A specified number of seats i.e., 5% of the intake capacity, subject to a maximum of 5 seats in each Government / Municipal Corporation / Government Aided Medical, Dental / Ayurved, Unani Colleges and some allied Health Science courses are reserved for children of Defence Service Personnel and Ex-Defence personnel, including those permanently disabled or killed in action. The ratio of these seats between Ex-defence and In-service Defence personnel is as given below.

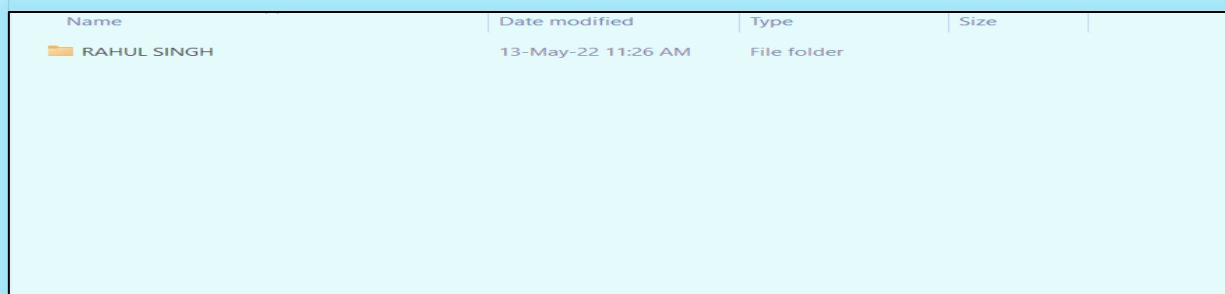

## M. CONDUCT AND DISCIPLINE:

### 17. CONDUCT AND DISCIPLINE:

17.1 Failure of the candidate in making full and correct statements in the application form and/or suppression of any information would lead to disqualification of the candidate, even at later date. Such a candidate will be debarred from the entire selection process.

17.2 It is responsibility of every candidate to submit proper documents. Any attempt to submit documents which are not genuine will lead to cancellation of the admission of the candidate, forfeiture of the fees, deposits and expulsion of the candidate from the college by the Competent Authority or by his authorised official. The name of such candidate/s shall be deleted from the State Merit List and he/she will not be eligible for further rounds of the selection process and will be debarred from the selection process. If deemed fit even criminal proceeding may be initiated by the Competent Authority against such candidates / their parents.

**If any candidate / authorised representative or person accompanying is found obstructing the counseling and / or admission process, or trying to influence in unlawful manner/ creating nuisance, the candidate shall be liable for disqualification from the process of selection and appropriate legal action will be taken. The decision taken by the Competent Authority in this respect shall be final and binding.**

17.3 The student while studying in the Health Sciences Courses, if found indulging in antinational activities, unlawful activities or ragging in any form, contrary to the provisions of relevant Acts and Law enforced by Government, will be liable to be expelled from the college by the Dean/Principal of the College.

17.4 Pursuant to orders in W.P. (Civil) No. 656 of 1999, Hon'ble Supreme Court of India, has directed the Department of Human resources Development and Education, Govt. of India, to take all necessary steps to curb the menace of ragging and take severe action against the students involved in such activities.

17.5 As per the provisions of Maharashtra Act XXXIII known as “**Maharashtra Prohibition of ragging Act of 1999**”, students indulging in ragging can be **punished under the Act resulting in suspension, expulsion from the college and imprisonment.**
