<b>1.</b>	<b>Eligibility Criteria</b>

The bidder must comply to the PCPNDT law and produce appropriate valid certification. The bidder must be preferably registered as AERB Certified Vender who is authorized as per latest list of AERB (Atomic Energy Regulatory Board) which can ensure as an added surety that appropriately experienced bidders only participate. Right to reject inappropriate firms on account of these documents is reserved with Dean Vilasrao Deshmukh Govt. Medical College, Latur.						
<b>1.2</b>	Must not be blacklisted by any Department of the Government of India or of any State/or by any PSU/Autonomous Organization of Government during last 05 years. An Undertaking regarding non-blacklisting of the bidder by any Government Organization must be furnished by the Bidder in tender documents in the format given in Annexure-V. Bids without above undertaking will not be considered.

	evidence of previous experience of similar procedure. Appropriate e Waste certification to be furnished. The bidder preferably should have a valid registration / license certificate of AERB so as to ensure that only bidders having experience of dismantling and disposal of high end specialized medical equipments bid.
8.7	The said equipment after dismantling should not be reused /recycled in the given condition and definitely not in any other form within the jurisdiction and geography of the main department (DMER) and in any way that it will harm system or persons.
